EXPLANATORY INSTRUCTIONS AND NOTES FOR THE COMPLETION OF THE APPLICATION TO ISSUE/REISSUE A PASSPORT OR A TEMPORARY PASSPORT (LAISSEZ PASSER)

Submitting the application: The application to issue/reissue a passport or temporary passport (laissez passer) should be submitted by the applicant in person to the competent District Authority or the Citizen Service Centre. Applicants who are not in Cyprus should submit this application to the closest Cypriot consular authorities/embassies of the Republic.

During the submission of the application the officer receiving the application will take the photograph and the finger prints of the applicant.

- A. Names in the Passport: The name and surname of the passport holder shall be printed in Greek or Turkish and in the Romanized system of writing. The name and surname of the passport holder will be transferred automatically into the Romanized system of writing with Latin characters. The applicants should complete their name in Greek or Turkish according to their Birth/Marriage Certificate. In case the applicants want their name to be written in a different way than the Romanized system, they can write it in Latin characters, on the second line under their name and surname.
- B. Declaration by the Applicant: The application should be fully completed and signed by the applicant if he is over 18 years of age.
- C. Declaration by Parents/Guardians: In case the application is submitted by a person under 18 years of age, the application should without exception be completed and signed in section VI by both parents or the guardian in the presense of the receiving officer. If parental care is exercised solely by one parent on the basis of a relevant order of the Family Court, the application shall be signed only by that parent. The order of the Family Court concerning parental care should be produced together with the application.
- D. At the submission of the application, the applicants should produce the following:
 - 1. Identity Card.
 - 2. Previous passport or Temporary Passport ((Laissez Passer) (where applicable).
 - 3. In case of loss of passport, a Police certificate to that effect.
 - A Marriage Certificate in the case of married women who desire the surname of their husband to be written in the passport.
 - The applicant shall produce any other documents, which may be requested by the officer receiving the application, in order to confirm the information contained in the application.
 - The relevant fees, for which a receipt shall be issued, are the following:

- Temporary passport (Laissez Passer)	€	20	
- Passport without biometric features	€	50	
- Passport with biometric features	€	70	
- Passport of limited validity	€	45	
- Diplomatic Passport	€	70	
- Service Passport	€	70

In case of first, second, third time etc loss or wear and tear or theft the fees are double those of the previous issue.

- Persons submitting the application for a Passport or Temporary Passport (Laissez Passer) for the first time should also produce the following documents:
 - i. Birth Certificate.
 - ii. Certificate of Cypriot citizenship if the applicant has acquired the Cypriot nationality by Naturalization or Registration.
